### My Personal Experience and Observations

*P#1 - 67 year old exposed to COVID-19 by her husband. No symptoms during two weeks of quarantine. Began EcoProven Mouth Rinse day 5 following symptom exposure.*

*P#2 - 67 year old COVID-19 physician, not hospitalized. Began EcoProven Mouth Rinse day 5 of illness during escalation phase of COVID-19. Details below.*

On day 3 of my illness, I picked my father up from the hospital and spent the remainder of our quarantine period together.*
